A considerable portion of Willamette Valley embraced within the boundaries of this county, and includes a large quantity of the most desirable agricultural and grazing land in the State. Veins of gold and silver quartz have been discovered in the eastern section. Acres of land assessed, 1865, 281,751; under cultivation, 30,683. Value of real and personal property, \$1,686,963. County seat, Eugene City.
