STOREY COUNTY. Boundaries—North by Washoe, east by Churchill and Lyon, south by Lyon, and west by Washoe. This is the richest and most populous county in the State. The land is not adapted for agricultural purposes, except what is found on the east bank of the Truckee River, which is of limited extent, but it is exceedingly rich in mineral wealth. The celebrated Comstock Ledge is situated within the limits of this county. The mines located thereon employ 76 mills, with an aggregate capacity daily of 1,800 tons, to crush the ore taken therefrom, a portion of which has to be conveyed on wagons for a distance of 18 miles to be reduced. The yield from this ledge for 1865 was nearly \$13,500,000, and it has been, and is, the principal source of revenue to the State, five-sixths of the taxable property having been within the limits of Storey, Washoe, Lyon, Ormsby, and Douglas counties, which depend for nearly all their business, directly or indirectly, on this lode. The Sutro Tunnel, an important enterprise, intended to drain the Comstock Lode 2,000 feet below the Gould & Curry croppings, has been projected. This, if successfully prosecuted, must result in adding largely to the mineral wealth of the State. County seat, Virginia City.
