Manhattan Eye and Ear Infirmary in that city. In 1881 Dr. Cornwall came to California, and commenced practice in San Francisco, which he has followed continuously ever since. Here he has justly acquired a high reputation for skill and proficiency as an oculist and aurist. He is a member of the State Eclectic Medical Society, and the County Society of Physicians and Surgeons. He holds the position of Professor of Ophthalmology, Otology, Rhinology, and Larynology in the California Medical College.

The doctor is not content to rest upon his laurels, but, recognizing his duty to his profession, he is engaged in the compilation of a work on Rhinology and Larynology, which will contain the latest scientific knowledge on these subjects. It is only recently that scientists have obtained a correct insight to the true nature of diseases of the nasal organ. It is largely through the researches and experiments of Dr. Cornwall that he has made special advances in the line of treating affections of the nose. His forthcoming work is designed as a text book for physicians, surgeons, and medical students, and will be a compendious treatise, containing all modern information that has been acquired touching the subjects of the work. The book will be published in the course of a year or so.

In conclusion we will say that Dr. Cornwall possesses a frank, open and generous nature, and he is most affable and engaging in his deportment and conversation. He impresses one at once with a belief in his sincerity and thorough reliability, and he is very popular with all his acquaintances. Leading members of his profession recognize his ability, and do not hesitate to display a hearty recognition of his skill and proficiency as a physician and surgeon, especially in the particular line to which he has devoted himself.

## P. O. CHILSTROM.

Among the advanced lawyers and thinkers of our city is Mr. P. O. Chilstrom. He was raised in Minnesota, a frontiersman, attending public school in the log schoolhouse of that day, but later taking a thorough course in college at Minneapolis. At nineteen he was merchandizing in Northern Minnesota, and later in Dakota. In 1873 he went to the mines of Colorado, and, returning in 1874, commenced the study of law with Hon. Eugene M. Wilson of Minneapolis. He was admitted to practice in 1876. He practiced law in Minnesota, Dakota, New York City, Washington (State), and in 1887 came to San Francisco, and for several years was a member of the law firm of Rogers & Chilstrom. Mr. Chilstrom has held various positions of trust in Minnesota, Dakota, and Oregon, and, had he yielded to the wishes of his friends, would have been much more prominently before the country. He was a consistent Democrat since casting his first vote for Greeley in 1872, up to 1892, when he became Populist, and was the candidate of that party, in 18,4, for Superior Judge of the City and County of San Francisco. A great admirer of the character of Lincoln, Mr. Chilstrom is now an houest Nationalist and Bimetalist, within the Populist ranks, believing that in more thorough and intelligent dealings with our economic questions, and strict adherence to the Constitution, lie the safety of our country. He believes in America for Americans, at all costs, and is always ready to promulgate and defend his belief.
