Section 5. Subdivision 1. Every person hereafter desiring to operate a motor vehicle as a chauffeur shall file in the office of the Secreatry of State, on a blank to be supplied by such Secretary, a statement which shall include his name and address and the trade name and motive power of the motor vehicle or vehicles he is able to operate, and shall pay a

registration fee of two dollars.

Subdivision 2. The Secretary of State shall thereupon file such statement in his office, register such chauffeur in a book or index to be kept for that purpose, and assign him a

number.

Subdivision 3. The Secretary of State shall forthwith, upon such registration and without other fee, insure and deliver to such chauffeur a badge of aluminum or other suitable material, which shall be oval in form, and the greater diameter of which shall not be more than two inches, and such badge shall have stamped thereon the words: "Registered Chauffeur No. ——, State of California," with the registration number inserted therein; which badge shall thereafter be worn by such chauffeur pinned upon his clothing in a conspicuous place at all times while he is operating a motor vehicle upon the public highways.

Subdivision 4. No chauffeur, having registered as herein provided, shall voluntarily permit any other person to wear his badge, nor shall any person while operating a motor vehicle wear any badge belonging to another person, or a fictitious badge.

Subdivision 5. No person shall operate a motor vehicle as a chauffer upon the public highways after thirty days after this act takes effect, unless such person shall have compiled in all respects with the requirements of this section.

Section 6. Any person violating any of the provisions of this act shall be deemed guilty of a misdemeanor, and upon conviction thereof shall be punishable by a fine not exceeding one hundred dollars, or by imprisonment not less than fifty dollars, nor more than one hundred dollars, or imprisonment not exceeding thirty days, or both, for a second offense; and punishable by a fine of not less than one hundred dollars nor more than two hundred and fifty dollars or imprisonment not exceeding thirty days, or both, for a third or subsequent offense.

SENATE BILL NO. 376

The People of the State of California, section 1. A new section is hereby added to the Penal Code of the State of California.

Section 1. A new section is hereby added to the Penal Code of the State of California to be numbered Section 367e, to read as follows:

367e. Any person operating or driving an automobile, motor cycle or other motor vehicle who becomes or is intoxicated while so engaged in operating or driving such automobile, motor cycle or other motor vehicle, or who by reason of such intoxication does any act, or neglects any duty, which act or neglect of duty causes the death of, or bodily injury to any person, shall be punishable by imprisonment in the State's prison not exceeding five years, or in the county jail not exceeding one year, or by fine not exceeding \$500, or by both such fine and imprisonment.

SENATE BILL NO. 378

The People of the State of California, represented in Senate and Assembly, do enact as follows:

follows

Section 1. A new section is hereby added to the Penal Code of the State of California to be numbered Section 367d, to read as follows:

367d. Any person operating or driving an automobile, motor cycle or other motor vehicle who becomes or is intoxicated while so engaged in operating or driving such automobile, motor cycle or other motor vehicle shall be guilty of misdemeanor, and on conviction thereof shall be punishable by imprisonment in the county jail not exceeding six months or by fine not exceeding \$500, or by both such fine and imprisonment.
