Operations of the Custom House.

Value of goods entered for duty, \$4,410,265; for warehousing, \$1,987,089; withdrawn for consumption, \$1,600,963; do. for export, \$238,226. The amount of cash received during the year 1857, \$1,507,019 50. Amount received 1856, \$1,675,108; decrease, \$168,088 50.

Operations of United States Branch Mint at San Francisco, for the year ending December 31, 1857.

Deposits of Gold, 1,067,594 ounces; do. of Silver, 45,314 ounces. Coinage, Gold Coin, \$20,407,000; Silver Coin, \$109,500; do. Bars, \$16,541. Total Coinage, including Silver Bars, \$20,533,041. The total Coinage for 1856, amounted to \$28,903,044. During the year 1857, the operations of the Branch Mint were suspended for the purpose of settlement and repairs, from the 23d of April to 10th of August, and again from the 1st to the 23d November.

Tonnage of San Francisco, 1857.

The number of vessels which arrived during the year is 1583. Total tonnage, 427,566; of which 1458, with a tonnage of 382,858, were American, and 125, with a tonnage of 44,708, were foreign. The tonnage for the year 1856, amounted to 345,897, of which 305,519 were American, and 40,378 were foreign; increase in 1857: American, 77,339; foreign, 4,330. Total 81,669 or nearly 24 per cent.

The number of departures during the same period was 848. Total tonnage, 337,022; of which 719, with a tonnage of 291,879, were American, and 129, with a tonnage of 45,143, were foreign. The tonnage for the year 1856, amounted to 389,260, of which 347,451 were American, and 41,809 were foreign.
