Atlantic Mails.—The great mails for the Atlantic States and Europe, leave on the 5th and 20th of each month, except either of these dates fall on Sunday, when the mail leaves on the succeeding day. The mail closes at the office fifteen minutes previous to the sailing of the steamer.

Great Overland Mail, from San Francisco

to St. Louis and Memphis, Tenn., *via* Los Angeles, Fort Yuma, Fort Fillmore nr El Paso, Preston and Fort Smith. leaves semi-weekly, Monday and Friday, at 12 o'clock, noon; mail closes at 11½ o'clock, A. M.

Central Overland Mail, from Placerville to St. Joseph, Mo., *via* Carson Valley and Salt Lake, leaves Placerville weekly, on Saturday at 12 o'clock, noon; mail closes at San Francisco every Friday at 3¼ o'clock P. M.

Mails for Sacramento and the Northern Mines closes daily at 3.50 P. M.; for Benicia, Vallejo, etc., at the same hour.

Mails for Stockton and the Southern Mines closes daily at 3.50 P. M.

Mails for San José, etc., closes daily at 7.50 A. M.

Mails for Monterey, Santa Barbara, Los Angeles and San Diego, are dispatched regularly on the 1st, 10th and 20th of each month.

Mails for Acapulco, Panama, South America, and the West Indies, per great Atlantic Mail, on the 5th and 20th of each month.

Mails for China, the Sandwich Islands, and Australia, are forwarded from the Post-Office by every suitable opportunity, containing all letters and papers, the inland postage of which is prepaid to San Francisco—leaving the sea postage to be collected in the ports where the mails are delivered.
