FRENCH BENEVOLENT SOCIETY, (Société Française de Bienfaisance Mutuelle.)—
Established 28th December, 1851. This is a Mutual Relief Society, established for the purpose of affording assistance to its members in case of sickness, and also for the relief of the indigent sick. The buildings at present connected with the society, are located on the corner of Bush and Taylor. A new and commodious hospital has been recently erected on Brannan Street between Simmons and Fifth, which forms

a very important addition to the charitable institutions of the city. Office of the society, 159½ Sacramento Street.

GERMAN GENERAL BENEVOLENT SO-CIETY.—Organized Jan. 7, 1854, with 105 members, Mr. G. W. Beckh as President. The intention of the society was to provide for the sick, and assist as much as possible all Germans, with particular reference to members and emigrants. At the organization a collection was made, and a special fund constituted for the erection of a hospital. On the 1st of May, 1855, a building was rented on Mission Street, and used as a hospital until the fund had so far accumulated as to allow the erection of a building for that pur-This being partly accomplished, another collection was made, two fifty vara lots 137½ by 275 feet, were bought on the south side of Brannan Street, between Third and Fourth streets; a brick building, 70 feet front by 50 feet deep was erected thereon, and on the 5th of January, 1858, the patients of the old hospital were removed to the new one. The new building has got two wards for ten patients each, one for six female patients, and nine rooms for the reception of one to two patients; it is capable to admit in all 50 patients. Steam, sulphur, cold and warm baths are fitted up in a neat and comfortable style. A garden has been laid out, 175 by 125 feet, and the center decorated with a fountain; a windmill supplies the garden and the house with water from an artesian well, 110 feet deep, which is first thrown on the top of the house into a reservoir capable to contain 2.000 gallons. The cost of the building, lot, furniture, bathing establishment, etc., amounts to about \$20,000, of which sums \$6,000 is unpaid yet.

The hospital has during the last three menths always had about 30 patients, who were maintained at a cost of \$700 to \$800, about \$500 of which were supplied by the society, and the

balance by paying patients.

The society numbers about 700 members, of whom two-thirds live in San Francisco, and one-third in the interior of the State. The monthly contribution is \$1, and the initiation fee is \$2. The members meet quarterly on the second Saturday of the months of January, April, July and October, in the Hall of the San Francisco Verein, corner Sacramento and Kearny streets, and elect a new board of directors at the first meeting in the year.
