The capacity of the works is equal to the manufacture of 400 tons of refined sugar and 20,000 gallons of syrup per month. On the premises are a steam-power cooperage shop, 20 feet wide by 100 feet in depth, for the manufacture of kegs and barrels; a bone-black manufactory, and two artesian wells, which discharge 70,000 gallons per day, 5 feet above the surface of the ground.
