

of the General Fund, fifty (\$50) dollars per month, to the Sheriff, which shall be in full satisfaction for the keeping and maintaining said horses.—[Act March 9, 1870.]

Protection of the Public.—To require, by ordinance, all contractors for street work, or other persons lawfully undertaking to improve, grade, or alter streets or public highways in the City and County of San Francisco, to erect fences or other suitable barriers to protect the public from damage, loss or accident, by reason of such grading, alteration or improvement, and to determine and prescribe the fines and penalties that shall be incurred for breach of such regulations and ordinances as may be passed by virtue hereof.—[Act April 25, 1863.]

Public Buildings.—To order paid out of the General Fund not to exceed twelve thousand dollars in any one fiscal year hereafter for repairs to Public Buildings.—[Act April 26, 1862.] To transfer to the Board of Education of said city and county, for Public School purposes, the building now occupied as a County Hospital, whenever the same shall not be required for a Hospital.—Act April 4, 1864.]

Public Grounds.— * * * excepting an allowance of two thousand dollars per annum heretofore provided by law for enclosing, improving and regulating all public grounds in said city and county.—[Act April 4, 1863.] For improving Columbia Square, six thousand dollars.—[Act March 14, 1868.] To appropriate, allow, and order paid out of the General Fund, a sum not to exceed ten thousand dollars for grading and fencing Hamilton Square, in said city and county.—[Act April 4, 1864.] For improving Washington Square, ten thousand dollars.—[Act March 14, 1868.] To allow and order paid out of the General Fund, a sum not to exceed five thousand dollars for improving Washington, Union and Portsmouth Squares.—[Act April 4, 1864.] For enclosing with wood the city and county property, including a portion of the land reserved for public use by the Outside Land Committee, fifteen thousand dollars.—[Act March 9, 1870.]

Public Offices.—From and after the first day of June, eighteen hundred and sixty-four, and after the purchase aforesaid, it shall not be lawful to pay out of the treasury of the City and County of San Francisco, or out of any public funds thereof, any money for rent of rooms or offices for Judges' Chambers, the City and County Attorney, the Board of Education, the Board of Delegates of the Fire Department, or for any other officer or officers of the said city and county; *provided*, that this section shall not impair any contract now existing.—[Act January 30, 1864.]

Public Pound.—To order constructed a common pound for all estrays, and to provide for the taking up and impounding of all animals running at large within the streets of said city and county, north of Johnston Street and east of Larkin Street [jurisdiction extended over the entire limits of the City and County of San Francisco—Act May 14, 1861]: *provided*, the cost of the construction of said pound shall not exceed five hundred dollars, which sum, or so much thereof as may be necessary, may be paid out of the General Fund by order of said Board of Supervisors. The said Board shall have power to make all needful rules and regulations necessary for the proper management and control of said pound, and may appoint one or more Pound Keepers, who shall be paid out of the fines imposed and collected of the owners of any animals impounded, and from no other source.—[Act April 23, 1858.] To allow and pay, out of the General Fund, a sum not to exceed five hundred dollars per annum, for deficiency in the salary of the Pound Keeper in said city and county.—[Act April 4, 1864.]

Railroads.—To have the power and authority to restrict all railroad companies, in laying down their tracks along the street of said city and county, to a space of not more than ten feet on each side of the center of such street or streets; and for a violation of such restriction the Board is hereby granted the power to prescribe and enforce such penalties as they may deem just and proper.—[Act March 21, 1868.]

*Roads.**—To allow and order paid out of the General Fund a sum not exceeding ten thousand dollars, in addition to the amount now allowed by law, for straightening, widening and otherwise improving that portion of the county road south of the Pioneer Race Course, and north of the county line of San Mateo County.—[Act April 26, 1862.] To allow and order paid out of the General Fund, not to exceed the sum of six thousand dollars in addition to the amount now allowed by law for repairing and improving roads south of Navy street, in said city and county.—[Act April 4, 1864.] To expend a sum not exceeding six thousand dollars per annum, for the building, improving and repairing of each of the road districts of the City and County of San Francisco. The repairs of said roads shall be ordered by the said Board, upon the written report of the Roadmasters of said road Districts. The Auditor of said city and county is hereby directed to audit, and the Treasurer of said city and county to pay out of the General Fund, all such sums of money as may be necessary for the building, improving and repairing of said roads; *provided*, that the same does not exceed the said sum of six thousand dollars for each district.—[Act April 4, 1870.]
