SAN FRANCISCO FEMALE HOSPITAL-This lospital was opened for the reception of pa-tients on the first day of April, 1868. The objects of the institution are the care of poor sick women. There is no rule as to nativity, religion, or social condition. It is a charity in the broadest sense of the term. Any woman who is poor and sick is entitled to share its benefits. It is a general hospital for all diseases, and for lying-in. During the three vears it has been open, there have been over 150 births: of the whole number of births over 50 per cent. have been illegitimate, showing conclusively the need of such an institution, as, if it were not for this hospital, the probabilities are that the greater number would have shared the fate of so many thonsands of innocents murdered in their mothers' womb. There have been besides a large number of patients admitted for general disease. During the existence of the hospital there have been but 15 deaths, mostly from that scourge of our race, consumption. There have also been a very large unmber of outside patients treated, the physician and surgeon being in attendance every morning from ten to eleven o'clock to treat any poor persons who may come. It was supported by voluntary contributions until the last Legislature, when the State appropriated \$5,000 a year for its support. The sur-great department is under the care of Dr.C.T.Deane. The hospital is located on the corner of Prospect Place and Clay Street.

SAN FRANCISCO LYING-IN HOSPITAL AND FOUNDLING ASYLUM. -- Incorporated April, 1868. For the care, protection, and proper treatment of respectable married and unprotected single women, with their offspring, together with all other children that may be left in infancy by outside parties. Said children will be considered foundlings.

The Trustees design to make this institution in the highest degree respectable and efficient, and available to women throughout every county in the State, regardless of religion, sectarianism or nationality, whether in poverty or affluence. Those who have the ability to pay, will be required to do so in proportion to their means, and this sum will be placed in the treasury to aid those less favored by fortune. It is expected that the institution will be supported by receipts from patients, donations and contributions from different sources, appropriations by the city and State governments, and in time, by bequests, legacies, etc., etc. Thus far the institution has been supported by contributions from citizens with the exception of

one thousand dollars received from the State, togeth er with about one tenth of current monthly expense. received from friends of patients. Suitable premises were leased on Jessie Street, east of Fourth Street. and enlarged to furnish twenty-two rooms, and made ready to receive patients Aurorat 1869. It is made ready to receive patients, August, 1869. It is a Special Hospital, and for the specialties for which it was organized, affords facilities not to be found elsewhere on this coast. No two patients occupy the same room, at the same time. No cases of disease are admitted for treatment. It is therefore expected that it will be kept free from erysipclas and other contagions diseases that become the bane of lying-in wards connected with general hospitals. It is thor-oughly ventilated, and will afford all the comfort that is to be found in the best conducted homes, and free from all intrusion. Competent nurses are in at-tendance day and night. To December 31st, 1871. ninety-one infants came under the care of the institution. Seventy of them were boin in the hospital and twenty-one left at the door of the a-ylum.
