

Brannan Street Bridge.—To expend a sum not to exceed four thousand dollars, payable out of the General Fund, for constructing a new bridge over Mission Creek, at Brannan street.—[Act February 14, 1866.]

Burning Bricks. To fix limits in said City and County of San Francisco, within which the burning of bricks shall be prohibited, and to make such rules and regulations in relation to the burning of bricks in any part of said city and county as they may deem advisable.—[Act April 5, 1861.]

City Cemetery.—To pay out of the General Fund, for inclosing and improving the City Cemetery, and paying keeper thereof, the sum of six thousand five hundred dollars.—[Act March 9, 1870.]

To pay Wm. P. Humphreys the sum of forty-eight hundred dollars, for making survey of, and plan for laying out the City Cemetery, erecting stakes, sign posts with names of avenues and walks thereon; also for furnishing an estimate of the cost of necessary improvements.—[Act Feb. 1, 1872.]

Contingent Expenses.—To allow and order paid out of the General Fund, a sum not to exceed one hundred and fifty dollars per month, to be expended at the instance of the President of the Board of Supervisors, for contingent expenses, other than those heretofore provided for, and of which he shall make a quarterly report to the Board.—[April 27, 1860.]

County Jail.—To improve, alter and enlarge the present jail building and property of said city and county, and if by them (Board of Supervisors) deemed expedient, for that purpose to purchase and receive additional land in said city and county, and to allow and order paid out of the General Fund, sums not to exceed the aggregate sum of twenty thousand dollars for the purposes mentioned in this section.—[Act April 4, 1863.] To order paid out of the General Fund, an amount not to exceed ten thousand dollars, said amount to be used in the construction of an additional number of cells in the County Jail.—[Act March 9, 1870.]

Election Expenses.—To allow and order paid out of the General Fund, for the election expenses of said city and county, not to exceed seventy-five dollars for each Election District for each election in said city and county.—[Act April 4, 1863.]

Fairmount Academy and Precita Valley Tracts.—To pay William P. Humphreys the sum of fifty-eight hundred dollars, for re-surveying the Fairmount Academy and Precita Valley Tracts, for making Block Books and Maps, and placing stone monuments to perpetuate said survey.—[Act Feb. 1, 1872.]

Fire Alarm Telegraph.—To appoint one Superintendent of the Fire Alarm Telegraph, at a salary of one hundred and fifty dollars per month [Act April 4, 1864], three assistants at a salary of one hundred and twenty-five dollars per month each [Act April 4, 1864, amended March 14, 1868], and one repairer at a salary of one hundred dollars per month [Act March 14, 1868.] To expend a sum not to exceed six thousand dollars for extension and repair to the fire alarm and police telegraph, payable out of the General Fund, and to appoint a competent person to repair and keep in order said fire alarm and police telegraph, at a salary not to exceed one hundred dollars per month, payable out of the General Fund. [Act February 14, 1866.] To expend a sum not to exceed fifteen thousand dollars for extending and repairing the fire alarm and police telegraph, payable out of the General Fund. [Act March 4, 1870.]

Fire Department.—To pay annually for running expenses, horse feed, repairs to apparatus, and other expenses of the Fire Department, the sum of thirty-five thousand dollars, in lieu of appropriation heretofore allowed by law.—[Act Feb. 1, 1872.]

To pay out of the General Fund, for running expenses and material for the Fire Department, the sum of twenty-three thousand one hundred and ninety-two dollars, which has heretofore been allowed by said Board and ordered paid in excess of allowances provided by law.—[Act Feb. 1, 1872.]

Gardeners, Public Squares.—To appoint four gardeners to take charge of Portsmouth, Washington, Union, and Columbia Squares, at a salary of seventy-five dollars per month.—[Act March 9, 1870.]

Gas for Public Buildings.—In case the Board of Supervisors of the City and County of San Francisco shall order any gas for the City Hall, engine houses, or any other public buildings, they are hereby authorized to audit and pay for the same out of the General Fund of the City and County of San Francisco as herein provided.—[Act March 6, 1858.]

*Gas Companies.**—To grant the right to lay down gas pipes in and through the streets of the City and County of San Francisco, and through said pipes to supply gas for the use of said city and county and the inhabitants thereof, for the term of fifty years, subject to the provisions of the Act by which this authority is granted. [Act April 27, 1863.]

* The Act of April 4, 1870, concerning Gas Companies provides that the authorities of every such town or city, including San Francisco, as aforesaid, may contract with any gas company for lighting the streets thereof; but no such contract shall be made at a fixed rate for a longer term than five years, nor at a variable or other rate for a longer term than ten years; nor shall any such contract be made at a higher rate than that now paid in the City of San Francisco.
