

General Fund, a sum not to exceed five hundred dollars per annum, for deficiency in the salary of the Pound Keeper in said city and county.—[Act April 4, 1864.]

*Railroads.*—To have the power and authority to restrict all railroad companies, in laying down their tracks along the streets of said city and county, to a space of not more than ten feet on each side of the center of such street or streets; and for a violation of such restriction, the Board is hereby granted the power to prescribe and enforce such penalties as they may deem just and proper.—[Act March 21, 1868.]

*Roads.\**—To expend a sum not exceeding six thousand dollars per annum, for the building, improving and repairing of each of the road districts of the City and County of San Francisco. The repairs of said roads shall be ordered by the said Board, upon the written report of the Roadmasters of said road Districts. The Auditor of said city and county is hereby directed to audit, and the Treasurer of said city and county to pay out of the General Fund, all such sums of money as may be necessary for the building, improving and repairing of said roads; *provided*, that the same does not exceed the said sum of six thousand dollars for each district.—[Act April 4, 1870.]

*Sheriff's Advertising.*—The official advertising of the Sheriff shall be included in the advertisement for proposals to do the city and county official printing, and shall be awarded to the lowest responsible bidder publishing a newspaper of general circulation in said city and county: *provided*, said award shall be made to the lowest responsible bidder, in the aggregate, for the whole of said city and county official printing and Sheriff's advertising.—[Act March 24, 1868.]

*Special Counsel.*—To allow and order paid out of the General Fund, not exceeding the sum of five thousand dollars for any one fiscal year, for the employment of special counsel.—[Act May 17, 1861.]

*Streets.†*—To order paid out of the General Fund, not to exceed seven thousand five hundred dollars, for cleaning sewers, cesspools, and street-crossings, in any one fiscal year.—[Act April 26, 1862.] To allow and order paid out of the General Fund, not to exceed eight thousand dollars per annum, in addition to the sum now allowed by law, for cleaning the streets, sewers, cross-walks, and highways of said city and county.—[Act April 4, 1862.] To allow and order paid out of the General Fund, not exceeding the sum of six thousand dollars in any one fiscal year, for repairs and improvements of streets fronting upon the water front of the city, as defined by an Act entitled "An Act to provide for the disposition of certain property of the State of California," passed March twenty-sixth, one thousand eight hundred and fifty-one.—[Act April 27, 1860.] To allow and order paid, out of the General Fund, not exceeding the sum of twelve thousand dollars, in any one fiscal year, for repairs to and improvements upon streets and sewers in front of property belonging to the city, other than those mentioned in the previous subdivision of this section.—[Act April 27, 1862.]

*Street-Light Fund.*—To order paid out of the General Fund any deficiency that may occur in the Street-Light Fund, for lighting the public streets.—[Act April 26, 1862.]

*Survey of Grade.*—To pay William P. Humphreys the sum of two thousand dollars for making survey and recommending grade in that portion of the city and county bounded by Channel, Harrison, Twenty-first, streets and Potrero Avenue.—[Act Feb. 1, 1872.]

*Titles to Engine-House Lots.*—To allow and order paid out of the General Fund the sum of one thousand dollars, for the purpose of compromising conflicting titles to engine-house lots, if the legal advisers of the said city and county shall deem such compromise expedient; this sum to be in addition to the amount now allowed by law.—[Act April 4, 1864.]

*Unclaimed Property.*—To provide for the safe keeping and disposition of all lost, stolen, or unclaimed property of every kind which may be in the possession or under the control of the Chief of Police of said city and county, or which may hereafter come into the possession of the Police of said city and county.—[Act April 25, 1863.]

*Urgent Necessities.*—To expend and order paid out of the General Fund, not to exceed two thousand dollars per month, for objects of urgent necessity.—[Act April 26, 1862.]

To pay out of the General Fund, for purposes of Urgent Necessity, the sum of thirty-one thousand dollars, which has heretofore been allowed by said Board and ordered paid in excess of allowances provided by law.—[Act Feb. 1, 1872.]

*Vehicles.*—To provide for the summary removal and disposition of any or all vehicles found during certain hours of the day and night, to be designated by said Board, in the streets, highways and public squares of said city and county, or such of them as said Board may designate; and, in addition to all other remedies, to provide by regulation, for the sale or other disposition of said vehicles so found in said streets, highways, or public squares, as aforesaid.—[Act April 25, 1863.]
