Hoise of Correction.—To make all necessary arrangements to utilize the labor of the prisoners ommitted to the Jail or House of Correction. The Board of Supervisors are empowered with he government of the same, and are authorized to appoint a superintendent, who shall also e treasurer, at a salary not exceeding two hundred dollars per month. Said superintendent to ppoint, subject to the approval of the supervisors, such subordinates as may be deemed necesry by the supervisors, who shall fix the compensation to be allowed to each, which shall not exceed one hundred dollars per month. Authority is also given to the supervisors to furish suitable material and implements necessary for the constant occupation of the prisoners. The labor of the prisoners may be let out on terms to be agreed by the Board, and the receipts erived therefrom to be appropriated to defray the expenses of the institution. The female risoners are to be kept separately, and are to be employed at such labor as they are able o perform.—I Act March 31, 1876.1

o perform.—[Act March 31, 1876.] Indigent Dead.—To allow and order paid out of the General Fund such sums as are now ue or may become due, for burying the indigent dead.—[Act April 27, 1860.]

Industrial School.*—To allow and order paid out of the General Fund a sum not to exceed hree hundred dollars per annum, for medical attendance upon the inmates of the Industrial school in said city and county.—[Act April 4, 1864.]

Inebriates and Insane Persons.—To appropriate from the fees and forfeitures collected in the olice Court, from persons arrested for being drunk, a sum not to exceed eight hundred dollars er month, to be paid to the officers of the Home of the Inebriates, wherein shall be cared for, without farther expense to the city, all persons charged with being insane and pending their exmination, or found to be insane and en route to a State insane asylum.—[Act March 18, 1876.]
