Surplus Funds.—If at the beginning of any month any money remains unexpended in a of the funds set apart for maintaining the municipal government of this city and county San Francisco, and which might lawfully have been expended the preceding month, such une pended sum or sums may be carried forward and expended by order of the Board of Supe visors in any succeeding month; provided, that said Board of Supervisors shall not hereaft make any contract for any purpose binding said city for a longer period than two years. -[A March 13, 1876.]

Tax Collector's Clerks.—To authorize the employment of such extra Clerks as may required by the Tax Collector in his office from time to time, at a salary not to exceed or

hundred and fifty dollars per month each.—[Act March 30, 1872.]

Urgent Neccssitics.—To pay out of the General Fund the sum of two thousand dollars pa

month for purposes of urgent necessity.—[Act April 26, 1862.]

Vehicles.—To provide for the summary removal and disposition of any or all vehicles foun during certain hours of the day and night, to be designated by said Board, in the streets, high ways, and public squares of said city and county, or such of them as said Board may designate; and, in addition to all other remedies, to provide by regulation for the sale or other dispositions. position of said vehicles so found in said streets, highways, or public squares, as aforesaid. [Act April 25, 1863.]

Watchman, Night.—To appoint a Night Watchman for public buildings, at a salary not t

exceed ninety dollars per month.—[Act March 30, 1872.]

Weigher of Coal.—To appoint a Weigher of Coal in and for the City and County of Sa Francisco, who shall reside in said place, and continue in office for the term of two years from the date of his appointment and until his successor is appointed and qualified. Said Weigher before entering upon the duties of his office, shall take and subscribe the oath of office, are give bonds in the sum of ten thousand dollars for the faithful discharge of his duties. Whe requested to do so by any person interested in knowing the weight of any coal, it shall be the duty of said Weigher to weigh all coal brought to his scales to be weighed, and, unless som other price be agreed upon by said Weigher and the person or persons making such request. In the person of t may charge and collect ten cents per ton for such service. Said Weigher shall have and main tain at suitable places such number of scales as he may deem necessary; but this Act shall no be so construed as to enable said Weigher to create any liability against said city and county.-[Act April 27, 1863.]

Supplemental XX.—An Act to confer additional powers, etc., approved April 23rd, 1876.

SECTION 1. The Board of Supervisors of the City and County of San Francisco are, hereby authorized and empowered to have the streets in said city and county kept clean, in the following manner: from the first of October to the first of April in each year they may employ not texceed twenty horses and carts with drivers and twenty-five additional men as scrapers and sweepers, and from the first of April to the first of October in each year, fifteen horses and cart with drivers and twenty additional men as scrapers and sweepers.

The Board of Supervisors shall appoint two competent persons to superintend said work, at a salary not to exceed one hundred dollars per month, per man, said superintenden shall each day report, at the office of Superintendent of Public Streets the name of all men, and men and teams employed the previous day and where employed; the report shall also contain

the license number on said carts employed.

The Board of Supervisors are hereby authorized and empowered to employ not t exceed ten men and three horses, carts and men to clean out and remove all sand and dirt that may accumulate in the public sewers.

The said Board are hereby authorized and empowered to appoint a suitable person
