Clerk.—SETH P. HOLWAY; appointed by the Mayor; salary \$1,800 per annum.

BOARD OF SUPERVISORS.

Term of office, two years; salary \$1,200 per annum; terms expire first Monday in December, 1877. Weekly meetings each Monday evening. Quarterly meetings first Monday in January, April, July, and October. Special meetings at the discretion of the President.

President.—ANDREW J. BRYANT; term expires December, 1877.

Attorney City and County.—WELLINGTON C. BURNETT; term expires December, 1877; salary, \$5,000 per annum.

Clerk.—JOHN A. RUSSELL; appointed by the Board; salary \$3,000 per annum.

Deputy Clerk.—SANDS W. FORMAN; salary, \$1,800 per annum.

Sergeant-at-Arms.—JAMES H. LYNCH; salary, \$1,200 per annum.
