1871, when he resigned. The Rev. Hugh Smith Carpen-1874, when he resigned. The Rev. Hugh Smith Carpenter, D.D., supplied the pulpit from February, 1872, to March, 1874, when he resigned. He was succeeded by the Rev. Alfred H. Kellogg, who commenced his services, as Acting Pastor, on the first Sunday of December, 1874. The present pastor was installed by the Presbytery of San Francisco October 10, 1875. The number of communicants enrolled is about five hundred.

The present church huilding was erected in 1866, and dedicated January 6, 1867. It will seat comfortably nearly one thousand four hundred persons, and is considered in all respects well adapted for the purposes designed in

This enterprise was commenced by Rev. J. D. Strong in the Spring Valley School House, in April, 1862. A Union Sabbath School, under the superlatendence of E R. Waterman, had previously existed in the neighborhood for more than two years, but was not formally connected with the church movement till near the close of tha year, when an effort was made to creet a house of wor ship, but falled for want of the requisite funds. the following summer the effort was revived, and in Sep tember, 1863, a Board of Trustees was incorporated, a lo purchased at an expense of \$1,000, plans and specifications prepared by S. II. Williams, and the contract fo building the church edifice let to J. W. Dancan. On the fourth of September, 1864, the building was completed and dedicated. It is of wood, seventy-two feet long and forty-two feet wide, and has sents for about four hundred persons. Its architecture is plain and unpretending but neat and tasteful.
