SAN FRANCISCO PORT SOCIETY.—Organized March, 1860. Objects: The moral improvement of seamen, and others connected with the sea, in this port, by aiding the American Seaman's Friend Society of New York in sus-taining the Mariners' Church of San Francisco, and in

such enterprises connected therewith as the society may approve. The society is organized and sustained on the principle that it belongs properly to the people of Cal-ifornia to provide religious privileges and instructions for the sailors belonging to and visiting this port. Any person may become a member by paying \$5 a year, or blick member by the prepared at one fine of \$50

In 1866 they erected a fine house of worship for the seamen of this port, on the corner of Saeramento and Drumm streets, at a cost, for lot and house, of more than \$20,000, the larger part of which was contributed for the purpose by citizene of San Excelored at the purpose hy citizens of San Francisco and others, and \$6,000, the balance, was raised by loan secured by mortgage on the lot. This has since been paid and the Society is now free from debt,
