Form of government, combined City and County, Board of Supervisors.

Population, 634,394 (1930 U. S.—official); 747,049, January 1, 1938 (Chamber of Commerce estimate).

Native white population: 441,583 (1930).

White population of age: Males, 53 per cent; females, 47 per cent.

Native born population (white) is 69.6 per cent of whole population.

Predominating nationalities in city are American, Italian, German, Irish, English, Canadian and Chinese.

Area, 45.20 square miles.

Altitude, sea level to 965 feet.

Average temperature, 56.1°. Daily mean maximum, 62.6°. Daily mean minimum, 50.2°.

Parks: 49, and 80 recreational centers.

Assessed valuation, \$991,235,246; all property, with \$3.871 tax rate (1937-1938).

City's funded debt is \$162,408,700 (July 1, 1937).

Limit of future bond issues, \$66,622,530.

Financial: There are twenty-two banks, 17 under State supervision and 5 national banks, with total deposits of \$2,576,310,046 (1936); resources, \$2,848,811,490 (1936); debits to individual accounts, \$10,637,827,000 (1936); clearings, \$7,230,152,000 (1936); time deposits, \$1,401,261,546 (1936); demand deposits, \$1,175,048,500 (1936).

Post Office receipts of \$9,345,838 (1936).

Telephones in service, 262,733 (1936).

Churches number approximately 294.

Building and construction: Value of building permits, \$19,927,148 (1936), number 7,434.

Real estate transfers total 7949, valued at \$62,266,277 (1936).

Industry: Number of establishments, 1961; employing 34,395 total wage-earners, paying wages of \$40,943,446, and having products valued at \$287,461,451 (1935 U. S. Mfrs. Census).

Trade: Territory (retail) serves 1,800,441 people within the trading area covering San Francisco Metropolitan Area, jobbing territory serves 3,065,116 people within a radius of 250 miles. Many firms distribute to the 11 Western States, as San Francisco is Western headquarters for 1500 firms of national distribution.

Hotels: There are approximately 1500 hotels, with total accommodations of approximately 75,000 persons. Newest hotel was built in 1930.

City served by 3 transcontinental railroads, as follows: Southern Pacific, Western Pacific and Santa Fe. The Northwestern Pacific serves the North Coast of California. The city is also served by 181 steamship lines.

Amusements: There are approximately 77 theaters, with a total seating capacity of approximately 83,357 persons. Largest theater or auditorium seats about 12,000 persons.

Hospitals number 31.

Education: Number of schools, 180 public, including 23 high schools and a number of parochial and diocesan schools. Number of pupils enrolled in public schools, 102,088; in private schools, 14,000 (est.)

There are 520,000 volumes in the libraries of the city.

City Statistics: Total street mileage, 877 miles, with 680 miles paved. Miles of gas mains laid, 1005; of sewers, 97 miles, main trunk; street railway, 398.84 miles. Capacity of water works (municipal), 65,120,000,000 gallons.
