

CALLS TO BUSINESS OFFICES

If you wish to secure information from the business office regarding a service order or account (or to place an order on existing service) on which the telephone number is known, ask the attendant at the PBX serving the business office involved, for the service representative handling the particular account; for example, "Please give me the service representative handling DOuglas 2-5997".

If no telephone number is involved or to place an order for new service, give the PBX attendant the name and address involved and she will connect you with the proper service representative.

DIRECTORY LISTINGS

Unless otherwise indicated, the extension number shown in this directory is that of a station connected with the GARfield 1-9000 PBX. The address of employees in the 140 New Montgomery Building is designated by room number only. The address of employees in other major buildings is designated by a room number, if any, followed by a code number indicating street address. In all other instances, street addresses are used. Directory changes, additions or deletions, should be reported immediately to the department employee responsible for preparing such information in order that this directory and the PBX operators' records may be kept up to date.
