

helpful hints to find listings quicker and easier

All listings are in alphabetical order.

To find the name:

1. Find the page. See key names at top corner. (Key names are the first and last names on each page.)
2. Find the column. Scan columns across top of page. Select column where name would be likely to appear.
3. Find the name. Check down the column to the name you want.

Government listings:

1. Yellow Pages — See GOVERNMENT OFFICES Easy Reference List of Frequently Called Offices. White Pages — See steps 2-5 below.
2. State offices — See California State of
3. City offices — See [Name of city] City of
4. County offices — See [Name of county] County of
5. Federal offices — See United States Government

Letters used as names:

1. Find at the beginning of the listings of that letter. Example: R L Institute — see beginning of the R's. It will be listed alphabetically.

Numbers used as names:

1. Find number as it is spelled. Example: 299 Corner Cafe — see Two Nine Nine Corner Cafe.

LIABILITY OF UTILITY AND CUSTOMER RESPONSIBILITY

LIABILITY OF UTILITY

The Pacific Telephone and Telegraph Company has tariff rules dealing with the limitation of its liability in connection with errors and omissions relating to telephone service. These rules do not apply to situations involving willful misconduct, fraudulent conduct or violations of law. There are special provisions dealing with gross negligence. If an error or omission has been made by the Pacific Telephone and Telegraph Company in your listing in the telephone directory, you may be entitled to relief under these tariff provisions. In many instances you may be eligible for a credit allowance in accordance with tariff rules. This information notice summarizes the provisions of such rules. For complete information on the tariff provisions, please contact the nearest "Pacific Telephone" business office. Thereafter, if you wish further information, you may call the California Public Utilities Commission in San Francisco or Los Angeles.

The purpose of telephone utility credit allowance and limitation of liability tariff rules is to relate the telephone company's responsibility for errors or interruptions to amounts not to exceed the pro rata charges for services rendered. The basic rule applicable to all telephone services is as follows:

Except as noted above and fully set forth in RULE NO. 14 OF SCHEDULE CAL. P.U.C. NO. 26-T, the liability of the utility for damages arising out of mistakes, omissions, interruptions, delays, errors or defects in any of the services or facilities furnished by the utility (including exchange, toll, private line, supplemental equipment, directory and all other services) shall in no event exceed an amount equal to the pro rata charges to the customer for the period during which the services or facilities are affected by the mistake, omission, interruption, delay, error or defect provided, however, that where any mistake, omission, interruption, delay, error or defect in any one service or facility affects or diminishes the value of any other service said liability shall include such diminution, but in no event shall the liability exceed the total amount of the charges to the customer for all services or facilities for the period affected by the mistake, omission, interruption, delay, error or defect.

The specific form of rule applicable to interruptions in exchange telephone service is as follows:

The utility shall allow, for interruptions in exchange telephone service of 24 hours or

more not due to conduct of the customer, an amount equal to the fixed monthly charges for exchange service multiplied by the ratio of the days of interruption to thirty days. When interruptions continue beyond 24 hours, credit allowance will be given in successive 24-hour multiples. Similar but not identical provisions apply to private line and other telephone services. For details of provisions covering allowances for interruptions in such other services you should call your nearest "Pacific Telephone" business office.

For errors or omissions in listings or advertisements in telephone directories, allowances are provided as follows:

A. For listings in telephone directories furnished without additional charge, an amount not in excess of the minimum monthly charge to the customer for exchange service during the effective life of the directory in which the error or omission occurred.

B. For listings in alphabetical telephone directories furnished with additional charge set forth in SCHEDULE CAL. P.U.C. NO. 17-T, an amount not in excess of the charge for that listing during the effective life of the directory in which the error or omission occurred.

C. For listings, additional lines of information and advertisements in alphabetical and classified directories furnished as set forth in SCHEDULE CAL. P.U.C. NO. 39-T, 40-T, and closed directories furnished as set forth in SCHEDULE CAL. P.U.C. NO. 59-T, 60-T, an amount based upon pro rata abatement of the charge in such degree as the error or omission affected the listing, additional lines of information or advertisement.

For information on allowances available in the event of errors or omissions in information records or in special directories, you should contact your nearest "Pacific Telephone" business office.

CUSTOMER RESPONSIBILITY

The customer assumes full responsibility concerning the right to use any name or address in a directory listing and agrees to hold the Utility free and harmless of and from any claims, loss, damage, or liability which may result from the use of such listing. The Utility does not undertake to determine the legal, contractual, or other right to use of a name or address to be listed in a telephone directory. The customer shall notify the Utility of any change on non-service address in writing.
